Current families may bill to Oncare before April 13. Camps fill based on the date registration with payment is received. If you register and pay by March 30, there is a \$15 per week discount. Wait lists will be created for classes that fill early. We will provide the morning snack; you will need to send lunch with your child each day. An "early bird teacher" is available at 8:00 each morning before camp with a reservation. Cost is \$3 per use. Please pay the early bird teacher directly each time your child arrives early. Refund Policy – Tuition, minus a \$50 processing fee per session, will be refunded if you cancel by May 1. There will be no refunds after May 1. There are no refunds for absences, illnesses, late withdrawals, or emergency closings.
